### Privacy- and cookie statement

The protection of privacy and the security of personal data are very important to T Comm Telematics. We therefore work closely with our contacts at various social media channels (including Facebook, YouTube and LinkedIn) to continue to) comply with all privacy conditions.

## Processing of personal data

We will carefully process the information you have left behind or placed (with the help of cookies, see below) on this website. In addition, the information provided by you, such as name, e-mail address, will also be processed. During processing, your privacy is protected by appropriate technical and organizational measures. T Comm Telematics uses a privacy policy and an information security policy to protect your data. The processing will naturally take place in accordance with the applicable (privacy) laws and regulations.

# **Processing purposes**

The personal data you have provided to us will only be processed for the following purposes:

- To contact you, for the benefit of our services;
- Sending a newsletter;
- For marketing purposes of T Comm Telematics;

If T Comm Telematics wishes to use your personal data in a different way than the above mentioned, this will only take place if you have given your permission for this.

## Who can view your data?

Only employees of T Comm Telematics and in exceptional cases third parties (such as our software provider) have access to your data. Our employees are contractually obliged to maintain the confidentiality of your data and with third parties we have concluded a processor agreement to guarantee your data and the protection thereof.

## Changes in the privacy- and cookie statement

T Comm Telematics reserves the right to make changes to the privacy and cookie statement at any time.

#### **Your rights**

You have the right to:

- request access to your data stored with us;
- submit a request for correction or deletion of your data;
- object to the use of your data in a specific way.

T Comm Telematics also uses cookies on its website. In this cookie statement you can read more about the cookies and how T Comm Telematics applies the cookies to its website and its affiliated websites and how your privacy is protected.



#### What is a cookie?

A cookie is a simple, small file that is sent with pages from this website. A cookie is stored by your browser on the hard-drive of your computer. Some of these cookies are necessary for the site to work; others help us to improve the website and make it more user-friendly. The information stored with the help of cookies can be sent back to our servers on a subsequent visit.

#### Collection of data

The information collected by means of cookies by T Comm Telematics is used for the following applications:

- For functional purposes: to facilitate navigation on the website of T Comm Telematics.
- For analytical purposes: to analyze the use of the T Comm Telematics website. This allows us

to see which pages are visited the most and where error messages occur.

 For testing page (parts): this allows us to adapt our website to the wishes and user experiences of our visitors.

#### **Google Analytics**

To streamline and analyze traffic on the website, Google Analytics is used. Through our website a cookie is placed from the American company Google, as part of the "Analytics" service. We use this service to track and receive reports on how visitors use the site. Google may provide this information to third parties if Google is legally obliged to do so, or if third parties process the information on behalf of Google. We have no influence on this. When you visit the website of T Comm Telematics, some information will be provided automatically (e.g. your IP address, date and time of visiting the site, the browser you use, the number of hits and duration of the visit on the website).

## Removal of cookies
